

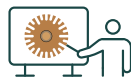
# COSAC Safe2Site Supervision Training (S2SST)

A supervisory role within construction requires you to have the ability to collaborate with other people and teams on-site, including contractors, employees and employers. Identifying hazards and risk on site is key to ensuring minimisation of accidents or injuries.

S2SST certification demonstrates you have the knowledge and skills to supervise effectively. It shows you're capable of promoting the health, safety and welfare of everyone on site under your supervision. It also ensures you can comply with all relevant legislation surrounding on-site operations and projects.

## THE COURSE
